CATC STUDENT PORTAL

1.0 Terms & Conditions

- 1.1 The use of the Civil Aviation Training Centre (CATC) Student Portal ("the Portal") is strictly bound by the Terms and Conditions listed herein. Use of the Portal is conditional on your acceptance of these Terms and Conditions.
- 1.2 All users are asked to read and understand fully all Terms and Conditions prior to logging on to the Portal. Do not proceed with accessing the Portal should you disagree with any of the Terms and Conditions. 2.0 Access Rights

- Only authorized staff in the employ of the Trinidad and Tobago Civil Aviation Authority
 (TTCAA) may be granted access to the Portal.
- Students registered for courses or programmes will also be granted access for the duration of the course or programme.

3.0 Security

- Each user shall be responsible for the security and use of his/her username and password. You are not allowed to use the account, username or password of any other user. You must not disclose your username or password to anyone other than the Student Portal Administrator.
