Subject: AIRMAN KNOWLEDGE TESTING AUTHORIZATION REQUIREMENTS MATRIX

TTCAA Advisory Circular TAC-PEL051

Date: 06/10/02

PURPOSE

1. (1) The purpose of this TTCAA Advisory Circular (TAC) is to provide guidance for applicants preparing to take airmen knowledge tests. Appendix 1 provides a quick reference for each airman knowledge test, any authorizations required to take the test, and retesting requirements.

GENERAL

- 2. (1) Specific requirements for each licence, authorization and rating are contained in the Trinidad and Tobago Civil Aviation Regulations (TTCARs), which can be obtained from the Trinidad and Tobago Government printery Victoria Avenue Port-of-Spain Trinidad.
 - (2) TTCAR No. 1 covers the requirements for Personnel Licensing.
- (3) Applicants should also consult other TACs for knowledge testing for a specific licence, rating or authorization.

- (a) Certificate of graduation or a statement of accomplishment certifying the satisfactory completion of the ground school portion of a course for the certificate or rating sought. The certificate or statement may be issued by a TTCAA certified Aviation Training Organization or authorized instructor.
- (b) Written statement or logbook endorsement from an authorized ground or flight instructor certifying that the applicant completed an applicable ground training or home study course and is prepared for the knowledge test.
- (c) Failed, passing or expired Airman Knowledge Test Report, provided the applicant still has the original test report in his/her possession. (See retesting explanation(s) below.)

3. Retesting Policies:

- (a) Applicants retesting after failure are required to submit the applicable score report indicating failure, along with an endorsement from an authorized instructor who gave the applicant the additional training, and certifying the applicant is competent to pass the test. The original failed test report presented as authorization must be retained by the test examiner and attached to the applicable sign-in/out log. The latest test taken will reflect the official score.
- (b) Applicants retesting in an attempt to achieve a higher passing score may retake the same test for a better grade after 30 days. The latest test taken will reflect the official score. Applicants are required to submit the original applicable score report indicating previous passing score to the Personnel Licensing (PEL) Office prior to testing. PEL Office personnel must collect and destroy this report prior to issuing the new test report.

5. Acceptable Forms of Authorization:

- (a) Certificate of graduation or a statement of accomplishment certifying the satisfactory completion of the ground school portion of a course for the certificate or rating sought. The certificate or statement may be issued by a TTCAA certified Aviation Training Organization.
- (b) Written statement or logbook endorsement from an authorized ground or flight instructor certifying that the applicant completed an applicable ground training or home study course and is prepared for the knowledge test.
- (c) Failed test report; or passing test report; or expired test report (pass or failure), provided the applicant still has the original test report in his/her possession. (See retesting explanation(s) below.)

6. Retesting Policies:

- (a) Applicants retesting after failure are required to submit the applicable score report indicating failure, along with an endorsement from an authorized instructor who gave the applicant the additional training, and certifying the applicant is competent to pass the test. The original failed test report presented as authorization must be retained by the examiner and attached to the applicable sign-in/out log. The latest test taken will reflect the official score.
- (b) Applicants retesting in an attempt to achieve a higher passing score may retake the same test for a better grade after 30 days. The latest test taken will reflect the official score. Applicants are required to submit the original applicable score report indicating previous passing score to the Personnel Licensing (PEL) Office testing centre prior to testing. PEL Office personnel must collect and destroy this report prior to issuing the new test report.

- (a) Requires no instructor endorsements or other form of written authorization.
- (b) Failed, passing or expired Airman Knowledge Test Report, provided the applicant still has the original test report in his/her possession. (See retesting explanation(s) below.)

9. Retesting Policies:

- (a) Applicants retesting after failure are required to submit the applicable score report indicating failure, along with an endorsement from an authorized instructor who gave the applicant the additional training, and certifying the applicant is competent to pass the test. The original failed test report presented as authorization must be retained by the examiner and attached to the applicable sign-in/out log. The latest test taken will reflect the official score.
- (b) Applicants retesting in an attempt to achieve a higher passing score may retake the same test for a better grade after 30 days. The latest test taken will reflect the official score. Applicants are required to submit the original applicable score report indicating previous passing score to the Personnel Licensing (PEL) Office prior to testing. PEL Office personnel must collect and retain the original report prior to administering the knowledge test. Once the applicant receives the new test report, the previously issued original must be destroyed.

- (a) Certificate of graduation or a statement of accomplishment certifying the satisfactory completion of the ground school portion of a course from an napproved Aviation Training Organization.
- (b) Written statement from an authorized ground or flight instructor showing satisfactory completion of the ground instruction required for the rating sought.
- (c) Written statement from an authorized ground or flight instructor, certifying that they have personally reviewed the applicant's completion of a home study course and found the applicant has satisfactorily completed that course.
- (d) Logbook endorsement from an authorized ground or flight instructor.
- (e) Failed, passing or expired Airman Knowledge Test Report, provided the applicant still has the original test report in his/her possession. (See retesting explanation(s) below.)

12. Retesting Policies:

- (a) Applicants retesting after failure are required to submit the applicable score report indicating failure, along with an endorsement from an authorized instructor who gave the applicant the additional training, and certifying the applicant is competent to pass the test. The original failed test report presented as authorization must be retained by the examiner and attached to the applicable sign-in/out log. The latest test taken will reflect the official score.
- (b) Applicants retesting in an attempt to achieve a higher passing score may retake the same test for a better grade after 30 days. The latest test taken will reflect the official score. Applicants are required to submit the original applicable score report indicating previous passing score to the Personnel Licensing (PEL) Office prior to testing. PEL Office personnel must collect and destroy this report prior to issuing the new test report.

14. Acceptable Forms of Authorization:

- (a) Requires no instructor endorsements or other form of written authorization for a ground instructor, flight instructor, fundamentals of instruction
- (b) Requires instructor endorsements or other form of written authorization for ground instructor instrument, flight instructor instrument for aeroplane or helicopter.
- (e) Failed, passing or expired Airman Knowledge Test Report, provided the applicant still has the original test report in his/her possession. (See retesting explanation(s) below.)

15. Retesting Policies:

- (a) Applicants retesting after failure are required to submit the applicable score report indicating failure, along with an endorsement from an authorized instructor who gave the applicant the additional training, and certifying the applicant is competent to pass the test. The original failed test report presented as authorization must be retained by the examiner and attached to the applicable sign-in/out log. The latest test taken will reflect the official score.
- (b) Applicants retesting in an attempt to achieve a higher passing score may retake the same test for a better grade after 30 days. The latest test taken will reflect the official score. - (b) Provide TTCAA with evidence of having met the knowledge requirements set out in TTCARs No. 1: Schedule 11, Part A.
- (c) Failed, passing or expired Airman Knowledge Test Report, provided the applicant still has the original test report in his/her possession. (See retesting explanation(s) below.)

21. Retesting Policies:

- (a) Applicants retesting after failure are required to submit the applicable score report indicating failure, along with an endorsement from an authorized instructor who gave the applicant the additional training, and certifying the applicant is competent to pass the test. The original failed test report presented as authorization must be retained by the examiner and attached to the applicable sign-in/out log. The latest test taken will reflect the official score.
- (b) Applicants retesting in an attempt to achieve a higher passing score may retake the same test for a better grade after 30 days. The latest test taken will reflect the official score. - (a) For the aircraft maintenance engineer tests, present to TCCAA a certificate of graduation or a statement of accomplishment certifying the satisfactory completion of the ground school portion of a course from an approved Aviation Training Organization.
- (b) For the IA, present to TCCAA evidence of the requirements in TCCAR, No. 1:169.
- (c) Failed, passing or expired Airman Knowledge Test Report, provided the applicant still has the original test report in his/her possession. (See retesting explanation(s) below.)

24. Retesting:

- (a) Requires a 90-day waiting period for retesting for the IA.
- (b) Applicants taking retests after failure are required to submit the applicable score report indicating failure to the testing centre prior to retesting. The original failed test report must be retained by the test examiner and attached to the applicable sign-in/out log. The latest test taken will reflect the official score.
- (c) Applicants retesting in an attempt to achieve a higher passing score may retake the same test for a better grade after 30 days. The latest test taken will reflect the official score. Applicants are required to submit the original applicable score report indicating previous passing score to the Personnel Licensing (PEL) Office prior to testing. PEL Office personnel must collect and destroy this report prior to issuing the new test report.

- (a) Present to TCCAA evidence of meeting the requirements for the licence or ratings.
- (b) Failed test report; or passing test report; or expired test report (pass or failure), provided the applicant still has the original test report in his/her possession. (See retesting explanation(s) below.)

27. Retesting:

- (a) Retests require the applicant presents a signed statement from an airman holding a licence & rating sought by the applicant. This statement must certify that the airman has given the applicant additional instruction in each of the subjects failed, and that the airman considers the applicant ready for retesting.
- (b) Applicants taking retests after failure are required to submit the applicable score report indicating failure to the testing centre prior to retesting. The original failed test report must be retained by the test examiner and attached to the applicable sign-in/out log. The latest test taken will reflect the official score.
- (c) Applicants retesting in an attempt to achieve a higher passing score may retake the same test for a better grade after 30 days. The latest test taken will reflect the official score. Applicants are required to submit the original applicable score report indicating previous passing score to the testing centre prior to testing. Testing centre personnel must collect and destroy this report prior to issuing the new test report.
